Dear sponsors,

Just a quick note to tell you how far we have come with the establishment of the Foundation. Because before something is a Foundation, quite a lot has to be done.

That's how we had to form a board. Together with Judith and Bert Beld we are going to pull this cart and we are very much looking forward to it. Judith will manage the secretariat, Bert actively thinks along, Pieter manages the finances and I have taken on the role of chairman. Judith and Bert live in Borne and that is not really next to Putten, so we arrange a lot via mail and app and that is fine.

After articles of association, policy plan and other administrative matters were ready, we were able to visit the notary who, completely selflessly, provided us with the necessary official documents. She can be called, Stephanie Scheiberlich of Kernnotarissen in Harderwijk: thank you again.



This allowed Judith to apply for the ANBI, Pieter to apply for a bank account in the name of the Foundation and I to build a

website, a requirement to obtain ANBI. The abbreviation ANBI stands for "Algemeen Nut Beogende Instelling". With a commitment of at least 90% of the income for a general useful purpose, we do not have to pay inheritance or gift tax, distributions that we make are exempt from gift tax and not entirely unimportant: you as a donor / sponsor can deduct your donation from the tax. On the other hand, we must be non-profit-making and we must serve the public interest.

We are now waiting to see if we have met all the requirements to get the ANBI status.

The website can be viewed at www.lwengokids.nl. I have also mentioned all the children who have a sponsor so far and of course we all hope that this page will be full soon. You can also help us by spreading the word about our Foundation through your network.

So far we have eleven children in our sponsor project and I have applied to Anthony for 3 new children. We have already emailed a lot back and forth to get all kinds of administrative matters done.

From April 8th we can organize an exhibition in the Wereldwinkel in Ermelo for the sale of products from Uganda. That's more Pieter's thing and falls under Make People Stronger. Definitely worth a look. As a Foundation we are hitchhiking on this exhibition and I am busy making leaflets. We are waiting for the ANBI, so that this can also be mentioned on the leaflet. Incidentally, our "graphic hustlers" can also be mentioned. I had put together a logo, but of course not professional enough. MegaDruk in Putten helped me selflessly with this.

We try to involve you as a sponsor as much as possible in growing up your own sponsor child. When we go to Uganda we sometimes bring t-shirts for the children and then we always wonder what size we will buy. The idea now is to measure the children when we are in Uganda in October and process this in a growth meter. The idea is still being developed. Perhaps you also have an idea or a question. If you reassure them, we can think about it together.

It remains for us to wish you a good Easter.
